**Excess:** No excess

**Co-payments:** Every time you go to hospital you will have to pay:

- \$100 per day for a shared room for overnight admissions
- \$100 per day for a private room for overnight admissions
- \$100 for day surgery (no overnight stay)
- The maximum co-payment is \$1,200 per year

[The following waiting periods for hospital admissions apply to new or upgrading members](#)

**Waiting periods:**

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments

## Other features of this hospital cover
