Excess: You will have to pay an excess of \$250 per admission. This is limited to a maximum of \$250 per person and \$250 per policy per year.

Excess payments do not apply to hospital admissions for day surgery or dependants.

Co-payments: No co-payments

Waiting periods:

- 2 months for palliative care, rehabilitation and hospital psychiatric treatments, even if pre-existing
- 12 months for other pre-existing conditions
- 12 months for pregnancy and birth (obstetrics)
- 2 months for all other treatments

Other features of this hospital cover

Benefits for speech and sound processor replacements are available on this cover where the replacement is clinically necessary and provided as an outpatient service.
