Other features of this general treatment cover

\$200 limit per person applies to Audiology. Combined Chiropractic limit increases at \$100 per year, up to \$1,000. A sublimit of \$375 per person applies to chiropractic, osteopathy and exercise physiology. Hearing aid limit increases from \$600 to \$1,600 based on tenure. Per hearing aid benefit is the total payable for hearing aids. Health Management Program limit of \$150pp / \$300 per family. Lower benefits apply for physio, chiro & osteo after 11th visit. A higher psychology benefit (\$75) may apply after Medicare Mental Health Treatment Plan is used up for the remainder of the calendar year.

Ambulance cover
